

# 2017 Cyprus International Food Festival

---

## Terms and Conditions

### **1. GENERAL**

1.1 Applications for participation should be submitted by 30 April 2017 to qualify for Early Bird Agreement and no later than 31 July 2017.

1.2 No person shall be entitled to participate without having paid the participation fee in full.

1.3 The exhibitor unreservedly undertakes the responsibility of complying with the participation regulations.

1.4 Apollon International Connections Ltd, has the exclusive right to interpretation, application, modification or withdrawal of any of the conditions and regulations of participation at any time. The decision of the above mentioned company to any matter or dispute which is not regulated by these conditions will be final.

1.5 Apollon International Connections Ltd, has an exclusive right to approve or reject any participation application and is not obliged to justify its decision.

1.6 The participation regulations with any modifications, additions or cancellations of them, the contract signed by both sides comprise the final contract between the exhibitor and Apollon International Connections Ltd.

### **2. SPACE**

2.1 The transfer, assignment or conferral of rights from the exhibitors to third parties is strictly prohibited, for all or part of the space they were granted as is the exchange of spaces between exhibitors without the prior written consent of Apollon International Connections Ltd.

2.2 Exhibitors are prohibited from bringing about any changes to the site. For all the works regarding the configuration of the space, the prior authorization of Apollon International Connections Ltd must be obtained.

2.3 Apollon International Connections Ltd, for purposes of better appearance and uniformity of the exhibition, has undertaken the construction of all stands and the exhibitors are obliged to accept the relevant decision of the company.

2.4 The space is assigned only for the festival for which the application has been made.

2.5 The interior design and placement of goods - exhibits is exclusively borne by the exhibitor. All work on the decoration and function of the stand must be finished by 3 hours prior to the opening of the festival. All goods and decoration materials must be removed from the exhibition on the day of closure by 23h00.

### **3. CHARGES**

3.1 The exhibition space is configured to serve the needs of the festival. The exhibitor has to select the stand as per the venue map and stand number.

3.2 The Exhibitor shall confirm participation according to the size of the stand selected. No stands shall be confirmed until full payment is received.

### **4. PAYMENT TERMS**

4.1 By signing the contracts, the exhibitor is obliged to pay 50% of the contract price with the remaining balance due by 30 July 2017. If balance is not received, the deposit shall be forfeited and participation cancelled.

4.2 The exhibitor is not entitled to refuse payment of any participation fee due to any claim against Apollon International Connections Ltd in relation to this agreement or to raise any objections to possibly justify additional charges.

### **5. CANCELLATION OF PARTICIPATION**

If the exhibitors decide to cancel their participation in the exhibition they should indicate their intention by 30 June 2017. In such cases, they will not be entitled to receive the sum paid as a deposit but they are exempt from the obligation to pay the balance of the agreement. In cases when a cancellation is made after the end of this deadline, the exhibitor must pay the full amount of the contract.

### **6. CANCELLATION OF EXHIBITION / POSTPONEMENT**

The company has the right to cancel / postpone the festival if it believes that for any reason the exhibition cannot be organized and must inform the exhibitors at least one month prior to its taking place. In such a case the Company will return the deposit amount to the exhibitors. Apollon International Connections Ltd bears no other obligation or liability or costs towards the exhibitors / customers.

## **7. CLARIFICATIONS OF CHARGES - OTHER CHARGES**

7.1 The participation fee for the festival in the general area is that indicated in the participation application.

7.2 The participation fee is calculated for all the square meters allocated to the exhibitor regardless of whether they use the entire area or parts of it.

7.3 The participation fee is paid in accordance with the conditions mentioned in the document-contract of participation.

## **8. RESPONSIBILITIES AND DUTIES OF EXHIBITORS**

8.1 The exhibitor must abide by the regulations and instructions of Apollon International Connections Ltd otherwise the organizer will be entitled to immediately close their stand, and they will have no right to raise any claims.

8.2 The exhibitor is responsible for any damage or detriment caused to the stand which they have been granted with or in the space it covers. They are obliged to deliver the stand and space in the same condition as they received it.

8.3 The exhibitor is responsible for the cleanliness of the stand.

8.4 The exhibitor is solely responsible for the behaviour of their staff and for any damage caused to persons or objects caused by them, their employees or guests.

8.5 The exhibitor is required to move the exhibits after the end of the exhibition by the time specified in paragraph 2.5. Any delay in moving leads to an additional charge.

## **9. STRICTLY PROHIBITED**

9.1 The cause of any form of nuisance to the exhibitors and the public.

9.2 Advertising of any kind outside the area provided.

9.3 Mentions to the detriment of another exhibitor, as well as those not related to the exhibition and the exhibits and advertising products of third parties.

9.4. Placement of objects and / or exhibits outside the allocated space or their placement so as to protrude from the showroom.

## **10. INSURANCE – SAFETY REGULATIONS**

10.1 The exhibitor is solely responsible for any damage suffered by the exhibits and any other assets from fire, theft, damage, loss or damage due to water leakage or damage due to any actions involved in fire extinguishing.

10.2 The exhibitor is responsible for any misfortunes or accidents of staff and/or exhibitors and/or or visitors in the showroom or the neighbouring showrooms that that might occur due to operating machinery or any electrical appliances or for any reason connected with their participation. They are also responsible for any damage or loss or accident caused due to their participation for which they or any person that gets instructions and/or orders from them are to blame for and affects the assets, furniture and buildings belonging to Apollon International Connections Ltd or/ and any third party.

10.3 During the non-working hours of the exhibition the premises are guarded by a private security company. Regardless, the exhibitors are urged to insure their goods against any risk. Apollon International Connections Ltd assumes no responsibility for any loss or damage to exhibits or other property of the exhibitor and / or employees.

10.4 The emergency exits of the stands must always be free and their passage or use must not be hindered by any objects.

10.5 The organizers insure the general area of the exhibition and other contiguous spaces that will be used for the exhibition against fire as well as accidents safety for its visitors during the opening times.
